Note:

- Client always has the option of paying the speaking fee in just 1 payment at the day of signing agreement.
- All checks should made payable to Primeco Education and mailed to the following address:

- All speaking fees are due 30 days before event starting date.
- All Speaker travel expense reimbursements are due no later than 7 days after the event ending date.
- Cancellation by Client more than 61 days of the event starting date permits Speaker to keep 50% of the deposit.
- Cancellation by Client less than 60 days of the event starting date permits Speaker to keep 100% of deposit.
- Cancellation by Client less than 30 days of the event staring date permits Speaker to keep 100% of speaking fee.
- Speaker will consider the cancelation funds for canceled events as part of payments for another speaking event scheduled by Client within six months of cancelation date and approved by the Speaker.
- For any cancelation situations, Client is responsible for reimbursement of any and all Speakers travel expenses due to cancelation or changing of the dates.
- There will be a 3% additional fee added to the speaking fees, if Client is using a credit card as the form of payment.
